Paul F. Brinkman, Esq.

Paul Brinkman is a trial lawyer in Washington office of Alston & Bird, one of the 250 largest law firms in the United States. His practice encompasses a wide variety of litigation matters generally relating to the international movement of goods and services.

Mr. Brinkman heads the firm's Section 337 unfair import practices litigation practice before the International Trade Commission and was nationally ranked in Chambers' 2008 and 2009 guides as a leading Section 337 practitioner. With the support of Alston & Bird's top-rated intellectual property group, he has had an unbroken winning streak in cases taken to trial since 1999, and is currently representing both complainants and respondents in several ongoing ITC investigations.

Mr. Brinkman served on the Steering Committee of the D.C. Bar's International Section from 2006-2009, is a fellow of the American Bar Foundation and has been co-chair of the American Bar Association's Customs Law Committee since 2007. He is listed in the 2009 edition of The Best Lawyers in America[®] in the specialty of international trade and finance law. Last fall he spoke at the AIPLA Annual Meeting on enforcement of ITC remedial orders and the ITC Trial Lawyer's Association annual meeting on the topic of foreign discovery in Section 337 matters.

Mr. Brinkman maintains an active pro bono practice, most recently arguing against the constitutionality of a Florida statute before the 11th Circuit Court of Appeals in June 2009. He enjoys biking to work in downtown Washington from his home in Alexandria, VA, and traveling with his family.

Robert W. Ebling, III (director emeritus)

Isotron (Alpharetta, GA / Boston, MA)

Bob Ebling is President and CEO of Isotron, a leading neutron radiation oncology company. Founded in 1998 in Georgia, Isotron has developed a patented radiation therapy system which uses neutron-emitting radiation generated by the Cf-252 isotope ("Californium 252") produced by the U.S. Government's Oak Ridge National Laboratories in Tennessee. This radiation is effective at eradicating tumors, including those of advanced stages which are uncontrollable with traditional radiation therapy techniques.

Prior to joining Isotron, Ebling had a distinguished career in the medical device, finance, and banking industries, and as a fundraiser in the not-for-profit sector. At U.S. Surgical Corporation he was Senior Director of Finance/Treasurer, responsible for funding the company; he raised over \$3 billion in various forms of debt and convertible debt during a nine year period. Previously, positions he held included: the Senior Vice President responsible for most U.S. large corporate banking for Barclays Bank in the 1980's; the CFO and President of The Hale Furniture Co. of Arlington, Vermont; a Managing Director and consultant with PricewaterhouseCoopers in its outsourcing line of business; the Senior Vice President-Development for the Hyde Schools, Inc.; and a senior member of the fundraising organization of Environmental Defense, Inc.

Ebling is a graduate (BS Finance) of the University of Vermont, and lives in Boston, Massachusetts and Pawlet, Vermont with his wife Gail. In addition to serving on Innovation Network's board, he is a director of The Concord Review, Inc. of Sunbury, Massachusetts; the National History Club, Inc. of Boston, Massachusetts; and previously served on the Board of Trustees of St. Luke's School in New Canaan, Connecticut and the Norwalk (Connecticut) Symphony Orchestra.

Until recently, Bob was an active alpine ski racing competitor. An avid golfer, he enjoys antique house restoration, and coaching and working with children. He recently transitioned to emeritus status after serving two terms on Innovation Network's board, including a term as co-chair.

Mark Gibson has over 22 years of experience in the construction, real estate operations, and outsourcing businesses. In his role as an executive with Ernst & Young, he specializes in business process assessments and re-engineering, project management, occupancy cost reduction, outsourcing, procurement analysis, and shared services assessments.

Mr. Gibson teaches project management at NYU and International Development at Columbia in their masters programs. Originally from the United Kingdom, Mr. Gibson spent eight years living and working in Asia (based in Hong Kong and Singapore) before moving to the United States. He is a Fellow of the Royal Institution of Chartered Surveyors. Mr. Gibson has managed over \$3 billion worth of projects and holds some of the highest qualifications in project management, including the Project Management Professional (PMP) qualification of the Project Management Institute. She was a Legislative Assistant to Senator Alan Cranston's for six years, advising him and negotiating on his behalf on all legislative and regulatory proposals concerning health and disability issues.

Prior to her work with Senator Cranston, Barbara managed outreach for the Southern California Federation of Scientists, and was a science journalist and broadcaster for KUNC-Public Radio Station in Colorado. She holds a B.A. in Molecular Biology from the University of California, Berkeley, and an M.A. in Molecular, Cellular, and Developmental Biology from the University of Colorado, Boulder. She also completed the Graduate Certificate Program in Science Communication at UC Santa Cruz.

Prior to joining NeighborWorks® America in 2006, Ms. Rutnik was the director of practice development at the Fannie Mae Foundation. Ms. Rutnik advanced the foundation's grantmaking strategy through the provision of technical assistance, research, and evaluation services for the program divisions. She also previously served as a senior evaluator and policy researcher at the Fannie Mae Foundation from 1997 to 2001. In that capacity she evaluated internal programs, directed the homelessness and community safety research grantmaking portfolios, and was an associate editor for the peer-reviewed journal, *Housing Policy Debate*.

From 2001 to 2005, Ms. Rutnik was the director of strategic initiatives and led the Funders Evaluation Initiative at the Association of Baltimore Area Grantmakers (ABAG), a regional association of grantmakers dedicated to strengthening and promoting organized philanthropy.
