

Our Approach

Three things set Innovation Network's evaluation practice apart:

- **Participatory Approaches:** Many nonprofits feel that evaluation is “done to” them. They see it as an invasive process carried out by people who don't care about their cause. This naturally creates resistance to the process, and makes evaluation results threatening instead of useful. Participatory approaches help to redress this problem. The people who care about a project—its staff and other stakeholders—are involved in the evaluation at every stage. This increases buy-in to the evaluation, and raises the likelihood that results will be put to practical use.
- **Capacity Building:** We focus on building our clients' ability to measure results for themselves. We create custom evaluation tools and processes for clients to use after our engagements—giving them the tools and skills to evaluate their own work.
- **Ongoing Learning:** For many nonprofits, becoming a learning organization is daunting. It requires new areas of focus, including defining what to reflect on and assess; confirming goals and outcomes; articulating resources required and activities needed to stay on task; and finally, identifying measures that will help the organization continually plan, evaluate, learn, and improve.

Ongoing Learning Cycle




We break the Ongoing Learning Cycle down into manageable pieces, to help organizations integrate learning into their day-to-day operations.

Our Services

Our projects range from **multi-year in-depth consultancies** to **90-minute web-based trainings**. We tailor our suite of services to fit each client's needs, budget, and learning style. There is no "typical" project, but the following elements are common across several of our engagements:

Evaluation Planning

- Needs assessment
- Understanding and defining outcomes
- Grantee-to-funder outcomes alignment
- Logic model (also called a "linear path" or "logframe") development



Data Collection & Analysis

- Key informant interviews
- Survey development, implementation, administration, and analysis
- Focus group development and facilitation
- Literature review and environmental scans
- Visual presentation of data and participatory data analysis
- Reports, presentations, recommendations, and lessons learned

Online and In-Person Training: Our training curricula are based on more than 15 years of consulting experience. Training modules include:

- The Fundamentals of Advocacy Evaluation

 - Evaluation Plans
