## **Position Summary**

The Research Analyst will be part of the Innovation Network consulting team, working closely with other members of the team and providing support in a variety of areas including research and analysis, data collection, and administrative support. This is a **two-year position** with the potential for ongoing employment.

Innovation Network is a national research and evaluation consulting firm. We are dedicated to making evaluation accessible to nonprofits and foundations. We believe in the power of data and storytelling to inform decisions, strengthen results, and create lasting change.
